Ms. Duncan was an Associate Professor of Health Studies at the University of Toronto and the former Research Director for the AIC Institute of Corporate Citizenship at the Rotman School of Management. A renowned international speaker, she has lectured for such organizations as the National Geographic Society, the Government of Japan, and the Young Presidents' Organization.

She sat on the Advisory Board for Pandemic Flu for the Conference Board of Canada, and the University of Toronto, and has helped organizations throughout Canada and the United States prepare for a possible flu pandemic. She also sat on the boards of the Indigenous Cooperative on the Environment, the Scottish Studies Foundation, the St. Andrew's Society of Toronto, and the Toronto Foundation for School Success. She co-chaired the 2006 Fraser Mustard Awards Gala in support of student nutrition and in October 2007, she chaired "Feeding Toronto's Hungry Students Week".

Ms. Duncan is passionate about helping build resilient communities and taking action on climate change. She has helped provide food, shelter and education to Toronto's youth, and served on the Nobel Prize-winning Intergovernmental Panel on Climate Change. She holds a doctorate in geography from the University of Edinburgh.

Georg Schütte has been State Secretary at the Federal Ministry of Education and Research (BMBF) since December 2009.

Prior to this, he had been Secretary General of the Alexander von Humboldt Foundation in Bonn since 2004, an organization which helps foreign scientists and scholars to spend research periods in Germany.

From 2001 to 2003, he worked as Executive Director of the German-American Fulbright Commission in Berlin and in this capacity was able to contribute to academic exchange and a better understanding between Germany and the United States. During this period, he was also a member of the EU Commission's expert group on 'Benchmarking Human Resources.' From 1998 to 2001, Georg Schütte was Head of the Strategy Department at the Alexander von Humboldt Foundation. After a period of working as a research assistant at the Foundation, he joined the junior academic staff at the University of Siegen and had teaching assignments at various universities including the universities of Lüneburg, Mannheim and Dortmund between 1995 and 1998.

Georg Schütte was a fellow of the Studienstiftung des Deutschen Volkes and a grantee of the German-American Fulbright Commission. Between 1984 and 1989, he studied journalism at the University of Dortmund and 'Television and Radio' at the City University of New York. He subsequently worked on his doctoral thesis at the Collaborative Research Centre "Screen Media" of Siegen University until 1994 and was a Visiting Fellow at Harvard University in 1992.

Georg Schütte is Chairman of the Founding Supervisory Board of the Berlin Institute of Health, of the Supervisory Board of the GSI Helmholtz Centre for Heavy Ion Research and of the Council of the Facility for Antiproton and Ion Research in Europe, of the Supervisory Board of the 'Germany Trade & Invest' foreign trade and inward investment agency, of the Board of Trustees of the Volkswagen Foundation, of the Board of Trustees of the German Federal Environmental Foundation (DBU), of the Board of the Bibliotheca Hertziana – Max Planck Institute for Art History in Rome, of the Council of the Stiftung Wissenschaft und Politik and of the Board of the German Fulbright Alumni Association. From 2008 to the end of 2009, he was a member of the university councils in Bonn and Siegen (chairperson in Siegen in 2009).

INDIA—Republic of India

Hon'ble Union Minister of Science and Technology and Earth Sciences Harsh Vardhan

Minister Vardhan [v uh r dh uh n]



Dr. Harsh Vardhan, at present Minister of Science & Technology and Earth Sciences, Government of India, was a practicing ENT surgeon before entering public life in 1993. He was elected to the Delhi Assembly that year from Krishna Nagar constituency in east Delhi and went on to retain that seat in all five elections in 1993, 1998, 2003, 2008 and 2013. In 2014, he contested the Parliament election for the first time and was elected to the Lower House (Lok Sabha) from Chandni Chowk. Delhi.

As Health Minister in the Narendra Modi government for five months, he initiated many reforms in the public health system of the country. He took over as Minister for Science & Technology and Earth Sciences in November 2014 with the confidence of the Prime Minister who earlier held this portfolio. He is committed to set a roadmap for the implementation of the "Make in India" programme by building a robust R&D infrastructure and promoting synergies between industry and scientific research institutions.

Dr Harsh Vardhan was born in December 1954. He decided to be a doctor and attended GSVM Medical College in Kanpur from where he obtained his MBBS and MS with specialisation in ENT. He held various posts in the Delhi Medical Association.

Dr Harsh Vardhan had pioneered the Pulse Polio programme in India. In 1994, on a single day (October 2, the birthday of Mahatma Gandhi), he organised the mass immunisation of 1.2 million children. No immunisation program in India before that had involved the marshalling of such awesome logistics. Interestingly, the entire program was also supported by school children who acted as "Polio Sena and Polio Sainiks". On 13th January 2012 India completed one full year without a case of polio being reported. In December 2004, Dr Harsh Vardhan came out with his own account on how he conceived and implemented the Pulse Polio program. The book, titled - A Tale of Two Drops (English)/ Kahani Do Boondo ki (Hindi), was released.

Dr Harsh Vardhan moved next to control tobacco consumption. As an ENT specialist, he was regularly confronting cases of laryngeal, oral and lung cancers – all attributable to tobacco use. In 1997, under his bold leadership, the Delhi Prohibition of Smoking and Non-Smokers Health Protection Act was passed.

A major pioneering initiative of Dr Harsh Vardhan was his act of implementing WHO's Essential Drug Programme, which revolutionised governments' attitudes on public health care. His missionary zeal touched other areas of health care as well. Under him, Delhi's Maulana Azad Medical College got the country's first ever Department for Occupational and Environmental Health. He launched the Matri Suraksha Programme to ensure proper mother and childcare for Delhi's middle and lower income groups. The Cancer Control Program, the Cataract Free Delhi Program and the Shravan Shakti Abhiyan for the rehabilitation of the elderly and the hearing impaired, were begun under his leadership. As Minister in Delhi Govt., he launched the Healthy





City Project, the Hepatitis B Immunisation Program and a Delhi Research Centre for Modernised Promotion of Ayurveda. Two other significant pieces of legislation that bear his stamp are the Delhi Physiotherapy and Occupational Therapy Act and Delhi Artificial Insemination Act.

Dr Harsh Vardhan has presented research papers at several national and international scientific conferences. He has also contributed to the world's leading medical journals.

Dr Harsh Vardhan was conferred the Paul Harris Fellowship by Rotary International twice. The International Institute of Polypathy based in Milan, Italy, nominated him as a Fellow in 1996. In 1995, the then President of Lions International, Mr C. Pino Grimaldi, awarded him the Lions International Service Award. In 1994, he received the "IMA President's Special Award of Appreciation" and was given the "IMA Special Award to Eminent Medical Men for Distinguished Achievement of Highest Order" for two successive years – 1995 and 1996. On "Doctor's Day", July 1, 2002, he was named "Doctor of the last Decade" (Swasthya Ratna) by the New Delhi branch of the Indian Medical Association for being the "noblest medical campaigner of the last decade".

He also served the South-East Asia office of World Health Organisation (WHO) as an Advisor. Dr Harsh Vardhan is a member of several prestigious organisations in not only the medical field, but also culture, diplomacy and related areas. He is a life member of the International Medical Parliamentarians Organisation, the Antar Rashtriya Sahyog Parishad, the Council for International Affairs and Human Rights, the Panchnad Research Institute, the IMA Academy of Medical Specialties, the Association of Otolaryngologists of India, the All India Rhinology Society, the Gems Association and the Delhi Society for Promotion of Rational Use of Drugs. He is also one of the founders of Green Forum, the country's first multi-party platform of leaders interested in environment protection.

As President of the Delhi Pradesh unit of the Bharatiya Janta Party (BJP), a position that he enjoyed four times. Earlier, he had also held the post of Vice-President of the party's national unit. In late 2003, he was nominated President of the Delhi unit of the BJP.

Married to Nutan, a specialist in hospital administration who preferred to be a homemaker. Dr Harsh Vardhan has two sons and a daughter.

Sander Dekker was born in The Hague in 1975, the oldest of three children. After finishing school, he went on to study Public Administration at Leiden University. Here he also obtained a Certificate of Higher Education in Dutch law and was president of one of the biggest student associations in Leiden.

After graduating in 1999, Sander Dekker stayed on at the university as a researcher and lecturer in public administration. In 2001, he was appointed visiting researcher at the Centre for European Politics, Economics and Society at Oxford University.

His political career began in 2003, when he was elected to the municipal council in The Hague representing the VVD, the Dutch conservative liberal political party. In 2006, he became deputy mayor of Education, Youth and Sport. He fostered policies aimed at reducing language problems, the number of school dropouts and youth unemployment. With success: during his period of office, the percentage of school dropouts in The Hague was reduced to the lowest of all the main Dutch cities, and the number of children receiving extra language tuition increased.

In 2010, he was deputy mayor of Finance and City Management, until he moved into national politics in 2012. As State Secretary, he is responsible for primary and secondary education. Compared with other countries, the quality of that education is good, but despite heavy investments and radical reforms, the level has remained the same over the past 20 years. Dekker now wants Dutch education to take a big leap forward. To achieve this, he plans to improve the quality of teaching staff, give ambitious schools more scope to distinguish themselves and challenge students to raise the bar higher. This particularly applies to gifted students, who tend to fare less well in the Netherlands than abroad. He also initiated a wide ranging consultation to review the Dutch curriculum.

Sir Rob Fenwick is the first New Zealander to be knighted for services to both business and conservation. He has a long association with Antarctica. He is Chairman of New Zealand Antarctic Research Institute which he founded in 2011. Prior, he was seven years Chairman of Antarctica NZ, the New Zealand Government agency responsible for supporting science on the continent and from 1999 - 2007 he led a global campaign to restore the historic huts built by Earnest Shackleton and Robert Flacon Scott on Ross Island a century ago. In 2005 the New Zealand Geographic Society named the Fenwick Ice Piedmont in the Ross Sea for his work in Antarctica. He has participated in sailing expeditions in both the Arctic and the Southern Oceans.

Sir Rob is a director of Te Papa Tongarewa (New Zealand's national museum) and a director of two National Science Challenges focussed on climate change and sustainable oceans. He was knighted KNZM in 2016; inducted to NZ Business Hall of Fame and New Zealander of the Year finalist in 2015 and knighted KStJ in 2007. He has an Honorary Doctorate in Natural Resources from Lincoln University (NZ).

Dr. John P. Holdren is Assistant to the President for Science and Technology, Director of the White House Office of Science and Technology Policy, and Co-Chair of the President's Council of Advisors on Science and Technology (PCAST). Prior to joining the Obama administration Dr. Holdren was Teresa and John Heinz Professor of Environmental Policy and Director of the Program on Science, Technology, and Public Policy at Harvard University's Kennedy School of Government, as well as professor in Harvard's Department of Earth and Planetary Sciences and Director of the independent, nonprofit Woods Hole Research Center. Previously he was on the faculty of the University of California, Berkeley, where he co-founded in 1973 and co-led until 1996 the interdisciplinary graduate-degree program in energy and resources. During the Clinton administration Dr. Holdren served as a member of PCAST through both terms and in that capacity chaired studies requested by President Clinton on preventing theft of nuclear materials, disposition of surplus weapon plutonium, the prospects of fusion energy, U.S. energy R&D strategy, and international cooperation on energy-technology innovation.

Dr. Holdren holds advanced degrees in aerospace engineering and theoretical plasma physics from MIT and Stanford. He is a member of the National Academy of Sciences, the National Academy of Engineering, and the American Academy of Arts and Sciences, as well as a foreign member of the Royal Society of London and former president of the American Association for the Advancement of Science. In December 1995 he gave the acceptance lecture for the Nobel Peace Prize on behalf of the Pugwash Conferences on Science and World Affairs, an international organization of scientists and public figures in which he held leadership positions from 1982 to 1997.
